#### 9 Second annual adjustment of salary

- (1) Employees' salaries are adjusted by 3.00%, with effect from 12 April 2023.
- (2) The adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) Schedule 1 has effect.
