## 2017 SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD 1 January 2017 to 31 December 2017

Pursuant to the Senate Order for Entity Contracts the following table sets out contracts entered into by Comcare which provide for a consideration to the value of \$100,000 or more (GST inclusive) and which:

- a. have not been fully performed as at 1 January 2017, or
- b. which have been entered into during the 12 months prior to 31 December 2017.
