## HSR Engagement Program

The HSR Engagement Program is aimed at providing development and networking opportunities to HSRs working within the Comcare scheme.

Comcare is offering employers the opportunity to purchase **two tickets for the price of one on a two-day full conference registration**. This reduces the ticket price from \$1,990.00 to \$995.00 (inclusive of GST) per HSR.

### Inclusions:

- Access to all conference sessions across 3 days
- Opportunity to network with delegates and conference partners in the Exhibition Hall
- A dedicated **HSR Connect** session to be held during the pre-conference workshop afternoon on Monday 14 September
- Morning tea, lunch and afternoon tea on Tuesday 15 September and Wednesday 16 September
- A ticket to the Conference Dinner being held at the National Museum of Australia on Tuesday 15 September.

All additional expenses including transport, accommodation, meals, transfers and incidentals are to be covered by the successful HSR's organisation (in adherence to their organisation's travel policy).

## Selection criteria

We ask that all HSR delegations are selected in consultation with their organisation's health and safety committee.

Applicants must be:

- A current HSR at an organisation that is covered by the Comcare scheme.
- A subscriber to Comcare's HSR network. This is easy to do through this [Comcare HSR Network subscription link](#).

At the conference, we encourage HSRs to attend the dedicated **HSR Connect** session, which will include networking time. There will also be an opportunity for delegates to participate in a short informal interview (optional) to discuss their experience at the conference as an HSR - we would love to hear your feedback!





## Application process

We ask that your organisation's health and safety committee (or equivalent) gathers nominations collectively.

Please provide the names and email addresses of nominated HSRs to [conference@comcare.gov.au](mailto:conference@comcare.gov.au) by **5.00 pm AEST Friday 10 July**.

Due to the limited availability of tickets, we will ensure an equal number of discounts are applied across agencies who have expressed interest.

If your nominations are successful, instructions on how to complete an online registration will be provided in late July including a final payment date.

- Nominations require written endorsement by the organisation's work health and safety unit or equivalent.
- Discount codes are unique to the individual HSR.
- In the event that a nominated HSR is unable to attend the conference due to leave, illness, injury or because they are no longer employed at the original organisation, you may transfer their registration to another HSR from your agency.
- Comcare will require notification in writing with a minimum of 72 hours' notice to assess the proposed replacement. Registration transfers made before/on Tuesday 11 August 2026 will not incur any cost penalty. Registration transfers made after 5.00pm AEST Tuesday 11 August 2026 will incur a \$110 processing fee.
